## we simplify mobility

**KMG INTERNATIONAL – Rompetrol Downstream** is the retail division of the KMG International Group in Romania. At the end of June 2022, Rompetrol Downstream's distribution segment comprised 1,222 sales points, including the network of own stations, partner stations and mobile stations (express, internal bases of 9 and 20 cubic meters), up by 154 units compared to the number recorded at the end of June 2021. In addition, the company also operates 6 fuel depots in Romania, about 200 car charging points with liquefied petroleum gas - LPG and over 7,000 distribution points for domestic LPG / Rompetrol cylinders. By means of expansion, diversified products and service range, including the possibility of charging electric cars or mobile applications, Rompetrol stations evolved to service centres and energy suppliers for customers.

Rompetrol Downstream developed specific products and services able to meet the proximity-related needs, introducing for the first time on the local market the cash withdrawal service. A unique concept "Zero Contact" was launched in 2020 through which customers, with Fill & Go fuel supply card, can refuel directly at the pump using online method for current bills payment. The retail division of the KMG International Group completed in 2018 the fitting of the first Rompetrol gas station with high-capacity solar panels, a premiere for Romania and the Black Sea region.
